

**NOTICE TO EXHIBITORS**

- \* This trial is open to all dogs registered with the UKC, 6 month of age or older.
- \* Trial will be judged under the current regulations (1/01/2013) of the United Kennel Club. Request rules from UKC at 100 E. Kilgore Rd., Kalamazoo, MI 49002 or <http://www.ukcdogs.com>.
- \*All dogs must be on-leash or confined when not competing.
- \*Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- \* It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and /or children. Any exhibitor whose dog(s) and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- \*Entry fees shall not be refunded in the event that the dog is absent, disqualified or excused by the Judge or Show Veterinarian. No entry fee will be refunded if the trial cannot open or be completed by reason of riots civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- \*Exhibitors are responsible for complete, accurate, and **legible information** on the entry forms: illegible or incomplete entries cannot be entered in the show.

**DIRECTIONS TO THE SHOW SITE:** From I-80 East or West, take I-29 South. From I-29 South, take the "Lake Manawa/IA School for the Deaf(East IA-92) via Exit #47. Turn RIGHT (south) US-275 (US-275 becomes WABASH AVE) go 2.2 miles. Turn LEFT onto PIONEER TRAIL ( JCT G66 county road) for 4 miles. Turn RIGHT onto 240<sup>TH</sup> ST which is a gravel road just past signs for Hyde Park & Mormon Trail Park. You will travel 1.2 miles south on 240<sup>th</sup> St., and it is the 4<sup>th</sup> place on the right, at the top of the hill, just after the bike trial: From I-29 North follow detour signs for 92/275. **11092 240<sup>th</sup> Street.**

**TRIAL SITE:** The trial will be held in an indoor air-conditioned building. Crating space is limited so please bring appropriate shade cover for those wishing to crate outdoors. Food will be available for purchase all 3 days. **THIS PRIVATE PROPERTY! PLEASE HELP US KEEP THIS WONDERFUL SITE! EXERCISE YOUR DOG RESPONSIBLY! PLEASE PICK UP AFTER YOUR DOG AT THE SHOW SITE AND HOTELS. ALL DOGS MUST BE ON LEASH EXCEPT WHEN IN THE RING.**
