Any exhibitor's entries may be refused for previous misuse of the motel/RV facilities. This is an AKC supported measure.

## **NOTICES TO EXHIBITORS**

The Show Site will be available to exhibitors at 7:30 a.m. Saturday, May 15th, 2020, and Sunday, May 16th, 2020. Dogs must be removed from the trial site immediately following the conclusion of the trials each day.

These trials will be held outdoors. Please bring shade tents, chairs, crates, water for you & your dog(s), rain gear (if needed), and clean up items. A cool-off tub will be provided.

<u>COVID-19</u>: Please read AKC's Suggested Best Practices for Herding on the Bellevue Dog Obedience Club website or AKC's Herding website. Bellevue Dog Obedience Club will send its own specific guidelines for this event when we send the judging program after the event closes.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all requirements safely.

Dogs may not be left in closed vehicles without proper ventilation. If dogs are found in distress, BDOC will take appropriate action.

All dogs present must be held on leash or otherwise restricted except when working. Under NO circumstances will dogs be allowed to disturb the resting stock or interfere outside the arena during another dog's performance. (See Chapter 1, Section 20 of the AKC herding regulations.)

Entry fees will not be refunded if a dog is absent, unless the dog is replaced by an alternate from the alternates' list; disqualified; excused; or barred from competition by action of the Judge or Trial Committee.

If, because of riots, civil disturbances, fire, acts of God, or other acts beyond the control of the host club, it is impossible to open or to complete a show or trial, no refund of entry fees will be made. BDOC reserves the right to cancel these trials in the event of extreme weather conditions and no entry fee refunds will be made in such case.

If, specifically because of current Iowa governmental authority or pandemic guidelines, it is illegal or impossible to hold this event, BDOC will update exhibitors and issue full refunds.

Exhibitors understand that they are entering this event at their own and others' risk. If an exhibitor needs to cancel entries after the closing date because of his/her own circumstances with COVID-19 exposure, special consideration will be given. Please contact the secretary.

Owners are responsible for errors on completed entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. Changes, additions, or corrections to entry forms must be received in writing, by telegram or e-mail prior to the close of entries. Those received by telephone are not acceptable.

Telephone, e-mail, and unsigned entries cannot be accepted. Entries not on an Official AKC Entry Form and photocopies of entry forms without the Agreement and Rules of the Official AKC Form are not acceptable.

Post-dated and returned checks do not constitute a valid entry. A collection fee of \$35.00 will be added to the amount of each returned check.

No refund for duplicate entries. Care will be taken to find duplicates, however, if an entry has been processed, no refund will be made.

No entry shall be accepted which specifies any conditions as to its acceptance.

No alcoholic beverages allowed on the trial site.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. There will be no refunds of entry fees, if a person is asked to leave the trial site.

Absolutely no dogs under 6 months of age are permitted on the trial grounds.

Exhibitors alone are responsible for being at the trial arena gate when it is their turn to run. Judges are not required to wait for any dog.

Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Management is not responsible for the loss of, damage to, or death of any dog exhibited, or for the possessions of any participant, whether the result of accident or any other cause. It is expressly understood that every dog at the show is in the care and custody and control of its owner or handler during the entire time the dog is on the show premises.

Bellevue Dog Obedience Club of Nebraska, Sunshine Farm, the trial secretary, their agents, employees, etc., assume no responsibility for any loss, damage, injury, or ILLNESS sustained by spectators, exhibitors, handlers, their employees, or children, etc., or to any of their dogs or property. Entrants and spectators to this show do so entirely at their own risk.

Bellevue Dog Obedience Club of Nebraska does not agree to arbitrate claims as set forth on the Official AKC Entry Form for these events.

From that Intersection: Go 2 miles South (right) on Hwy. 275 (Wabash Ave.), turn left (East) on Pioneer Trail, go 4 miles East, then turn right (South) on 240th Street.
