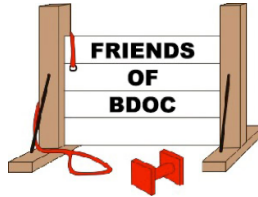

Entry Method: First Received without an Opening Date	Entries may be mailed or hand delivered anytime once the premium has been published. Note: Overnight envelopes must have the recipient's signature waiver signed or the envelope may be refused.
No more than six (6) entries are allowed per envelope. The only exception is all dogs within one (1) envelope have the same five (5) digit CPE member ID number.	
Entry Closing Date:	Final Closing Date: Wednesday, June 12, 2024, at 6:00 p.m. CDT Entries must be received by that date and time at the secretary's home.
No Refund of Pre-Entries withdrawn after the closing date. For entries withdrawn before closing, your check will be shredded. All checks will be held until the closing date. A \$35 collection fee will be added to the amount of any returned check.	
Limits:	100 runs per judge per day
There will be a warmup area containing boxes with the odors to be used. Exhibitors are not allowed to bring their own odors or practice boxes. To do so will result in being excused from the trial.	
NO DAY OF TRIAL ENTRIES	
CONTAINER & INTERIOR CLASSES WILL BE HELD INDOORS. EXTERIOR & VEHICLE CLASSES WILL BE HELD OUTDOORS RAIN OR SHINE AND MAY REQUIRE WALKING ON STEPS OR OTHER UNEVEN SURFACES.	
Same day move-ups will be allowed between rounds. Move-ups will be allowed for the next day.	
Crating will be in or near your car. Easy-Up Tents are permitted. You will receive specific trial information when you are sent the judging program.	

NOTICE TO EXHIBITORS

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and their dogs are familiar with the odors.
- Entry fees will not be refunded if a dog is absent, disqualified, excused, or barred from competition by action of the trial committee.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/ or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In that case, no refund of any fees paid will be made.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- Exhibitors are responsible for complete, accurate, and legible information on the entry forms; illegible or incomplete entries cannot be entered in the trial. For adjusted entries, no refunds are given. Exhibitors may write a new check.
- No prong collars; and no electronic or training collar devices (this includes shock & bark collars) are allowed on the grounds of a CPE trial.
- Lunch is NOT available for purchase at the trial site. Bring your own food and drink.
